### Folding Display

#### Contest Rules:

- 1) All entrants must be Junior Members of the WGBA.
- 2) There will be three age divisions in the Multi Media Contest. Only first and 2<sup>nd</sup> place will be awarded
  - Senior - Born between and including Jan. 1, 2006 – Dec. 31, 2008
  - Intermediate - Born between and including Jan. 1, 2009 – Dec. 31, 2012
  - Junior - Born between and including Jan. 1, 2013 – Dec. 31, 2017
- 3) Entry title or theme is due by February 20th. **The theme must be dairy industry related.**
- 4) All entries must be exhibited at the WGBA Convention on Friday March 6th. Awards will be given on March 7<sup>th</sup> at the Youth Awards program; but junior members do not need to attend to participate.
- 5) A junior member may enter as an individual OR as a member of a group. All group entry members must be in the same age division.
- 6) Display should be no larger than 3' x 4' and should be able to stand by itself.
- 7) Displays will be judged on content, organization, originality and neatness.
